#### 401 Recreation area

a) Phase 2/Wren Application.

Cllr Davey said that he had seen the email from Playdale asking if the Council were satisfied with the instillation. Cllr Davey said that he was not happy about the matting under the swings. The fitters have just added another piece of grasslock and there is a gap and it will not be long before the children will pull it up. Cllr Daniels said that this was not part of the instillation but a repair and it was not under guarantee.
