A Parishioner requested a progress report with regards to the Skatepark. Cllr Payne advised it will be reviewed and fundraising will commence next year. The Parishioner said she was happy to begin raising awareness and funds as soon as possible and enquired if it was possible to start a Facebook page. Cllr Davey stated a Facebook page would be fine and Fundraising could commence and would be supported by The Parish Council.

A Parishioner enquired is The Parish Council would be laying a wreath for the 11 November service at The War Memorial. Cllr Payne advised The Parish Council focus on the Church ceremony.

Buses were discussed, Stagecoach have given notice to terminate the contract concerning buses to and from Smithdon High School. County Council are working to replace the buses as they are duty bound to do for children getting to their catchment area, however those children travelling outside their catchment area for example Wells High School will only get limited assistance from Norfolk County Council.

Cllr Dark has a limited amount of Personal Budget including getting highways items on the agenda and asked if there were any areas within Dersingham that he could help with? Cllr Payne suggested that a bus stop outside the new Village Centre/ Doctors Surgery. Borough Cllr Bubb suggested the flooding at Church Lane be dealt with.
