677 Declarations of interest

678 Minutes of the Recreation Committee Meeting of 6 March 2017

Cllr Payne proposed that the minutes be signed this was seconded by Cllr Hopkins. **It was resolved for the Chair to sign the minutes as a true and accurate record.**

679 Matters Arising

Eight-Seater Bench

The Clerk advised that wooden benches were coming out from £180.00 and recycled plastic around £700. **It was resolved for the Clerk to get pictures of the recycled ones and email round.**

680 Recreation Area

a) Inspection Reports. Mr Blackwell was producing weekly reports and the Clerk was attending to any issues. Mr Blackwell had reported that the outside wetpour on the roundabout was loose and coming up. The Clerk advised that she had reported and it would be replaced by Playdale urgently. Mr Blackwell noted that the gate at both ends of the park needed attention and several items that needed bolts tightening up which was achieved and now a couple of weeks later need undertaking again. **It was resolved for Mr Blackwell to continue to tighten as necessary and for the Clerk to chase up the Bank Road Gate and look into replacing the self-closure on the gate by the Allotments on Station Road.** Cllr Davey advised that the Committee should look into a disabled swing. **It was resolved for the Clerk to obtain quotes for disabled swings.** Mr Blackwell said that he had been asked about adult exercise equipment. Cllr Payne advised that it was originally the next phase and will be looked at after the Village Hall is finished.

b) Kissing Gate

Cllr Payne advised that this has been pushed open again. **It was resolved for the Clerk to chase the order for the removal.**

Trees of Heaven

The Clerk advised that these should have been removed last week. **It was resolved for the Clerk to chase.**

c) Goal Post

The Clerk advised that these should have been filled last week. **It was resolved for the Clerk to chase.**

Cllr Hopkins said that it would be taken to the Sports Ground AGM when the clubs will be asked what they would be doing. **It was resolved for the Clerk to produce a booking form as soon as possible and to send to everyone showing an interest.**

b) Christmas Fayre/Light switch on 26 November 2017

This needs to be booked with the Borough Council and an event plan achieved. The Village Party booking form can be used for this also. Cllr Payne said it would be a good idea to close the Recreation Ground on the Saturday so that the ground can be set up for the Sunday. Mr Blackwell to see if someone is prepared to watch everything overnight.
