#### 1 Respective responsibilities of the body and the auditor

#### 2 External auditor report 2020/21

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

- The prior year annual return had an 'except for' matter raised by the external auditor where the smaller authority confirmed that it did act as sole managing trustee for trust funds, however in the current year Section 1, Box 9 and Section 2, Box 11 have been answered as 'N/A' and 'No' respectively.

Other matters not affecting our opinion which we draw to the attention of the authority:

The AGAR was not accurately completed before submission for review. The AGAR had to be sent back for amendment.
