**371** Norfolk County Council's Minerals and Waste Plan - Cllr Shepherd advised about a consultation by NCC on this long-term countywide plan. Concerns had previously been raised about the potential for silica sand extraction to the northwest of the village. The proposal to define areas of search had been dropped and a criteria-based policy was proposed. After discussion it was agreed to comment about policies MP2 and MPSS1 because of a conflict between the policies in respect of accessing the existing processing plant at Leziat.
